NOTICE OF NON-JUDICIAL FORECLOSURE SALE

WHEREAS, that certain Deed of Trust (the **"Deed of Trust"**), dated June 6, 2018 from James Earl Perkins II and Chelsae Ann Perkins (**"Borrower"**), as Grantor to Linda Booker, Trustee, filed for record on June 14, 2018 in Real Property Records of Coke County, Texas in Vol. 308, Pages 0082 - 0085, more particularly described therein, which serves as security for a \$35,900.00 promissory note described therein (the **"Note"**) executed by Borrower payable to the order of Chris Hinkle Real Estate, LLC.
