Commissioner Chisholm reported to the court that the Senior Center is complete aside from the awning. He also reports that the Bronte Recreation Hall is complete and in use. Commissioner Chisholm announced that preparation and park work for Bronteoberfest will start on October 1st.

Judge Spain reports to the court that the Food Bank distribution will be conducted in Bronte at 10:00 a.m. on September 23rd. He also announces a Special Court Meeting will take place on Monday, September 29th, 2025.
