## NOTICE OF PUBLIC HEARING ON TAX INCREASE

A tax rate of \$0.212720 per \$100 valuation has been proposed by the governing body of WEST COKE COUNTY HOSPITAL DISTRICT.

PROPOSED TAX RATE \$0.212720 per \$100 NO-NEW-REVENUE TAX RATE \$0.198382 per \$100 VOTER-APPROVAL TAX RATE \$0.212727 per \$100

The no-new-revenue tax rate is the tax rate for the 2025 tax year that will raise the same amount of property tax revenue for WEST COKE COUNTY HOSPITAL DISTRICT from the same properties in both the 2024 tax year and the 2025 tax year.

The voter-approval rate is the highest tax rate that WEST COKE COUNTY HOSPITAL DISTRICT may adopt without holding an election to seek voter approval of the rate.

The proposed tax rate is greater than the no-new-revenue tax rate. This means that WEST COKE COUNTY HOSPITAL DISTRICT is proposing to increase property taxes for the 2025 tax year.

A PUBLIC HEARING ON THE PROPOSED TAX RATE WILL BE HELD ON September 2, 2025 AT 9:30 AM AT 712 Washington St., Suite D, Robert Lee, Texas 76945.

The proposed tax rate is not greater than the voter-approval tax rate. As a result, WEST COKE COUNTY HOSPITAL DISTRICT is not required to hold an election at which voters may accept or reject the proposed tax rate. However, you may express your support for or opposition to the proposed tax rate by contacting the members of the of WEST COKE COUNTY HOSPITAL DISTRICT at their offices or by attending the public hearing mentioned above.
